Government confirms allocations of £500 million additional funding for councils

Local Government Secretary Robert Jenrick has this week confirmed allocations for individual councils from the £500 million of additional support for coronavirus-related spending pressures.

The extra £500 million – which brings support for pressures they are facing to £4.3 billion - will be distributed to councils based on population and levels of deprivation, and how the costs of delivery of services varies across the country.

Of the £4.3 billion provided to councils, £3.7 billion is not ringfenced to give more flexibility on how it is used in local areas and £600 million was to support social care providers.

In addition, the government announced a co-payment scheme that will compensate councils for irrecoverable income losses from sales, fees and charges. Councils will be expected to absorb the initial 5% of losses compared to planned income from these sources. Thereafter, there will be a cost splitting arrangement where 75p in every pound of relevant losses will be compensated for by the government.

To support longer-term budget planning, the government is also allowing councils to spread tax deficits over 3 years rather than the usual 1 year to allow authorities to pay deficits off in a reasonable timescale and limit cashflow pressures.

Infrastructure, Planning & Housing

New planning rules to protect our cultural heritage - Changes to the planning system will save theatres, concert halls and live music performance venues for future generations, Communities Secretary Robert Jenrick has announced. Councils will need to take the temporary impact of coronavirus into account when considering permission for change of use, redevelopment or demolition of a theatre, concert hall or live music performance venue [details here].

Rail Needs (HS2) Assessment Interim Report - The National Infrastructure Commission (NIC) published its Rail Needs (HS2) Assessment Interim Report on the 15th July 2020 – available <u>here</u>. The report summarises the evidence to date and sets out next steps towards finalising the Assessment by November 2020. The Assessment will include a number of alternative packages of interventions for Government to consider, based around the NIC's 'fiscal mandate'. The Government will then publish its preferred way forward in an 'Integrated Rail Plan for the north and Midlands' by the end of 2020. Employers' Information

COVID-19 Workforce survey research report, 14 July 2020 - EMC has been supporting the LGA with a national survey of key workforce data on how the sector is responding to COVID-19. It is a bi-weekly survey and EMC is coordinating the data collection from councils within this region. The report which summarises the results of the latest round of data collection is now available. The overall response rate was 65 per cent. The response within the East Midlands was 69% of councils providing their input. The full report is available from here.

Key findings

- Some 32 per cent of councils reported recruiting additional staff (of any type including casual, agency, contingent, etc) in the week ending 26 June 2020. In total 1622 additional staff had been recruited: the median number of staff per authority was four and the mean was 25
- More than a third of councils (108) recorded deaths in service since lockdown. A total of 205 deaths were reported since the start of lockdown (cause not specified).
- Thirty-three per cent of councils reported that they had furloughed at least one member of staff. In total there were 13,180 staff furloughed in the week ending 26 June 2020, which was two per cent of the current workforce. Of those councils that had furloughed staff, the median number furloughed was 101 and the mean was 169 but this varied considerably across different types of authority. The main reason given was that the service had stopped (57 per cent) or that funding had stopped (36 per cent).
- Some 82 per cent of councils had redeployed staff. In total there were 15,966 staff redeployed in the week ending 26 June 2020, which was three per cent of the current workforce. The median number of staff redeployed was 31 and the mean was 76.
- More than nine out of ten councils (92 per cent) reported that they had at least one member of staff unavailable for work. In total there were 33,077 staff unavailable for work in the week ending 26 June 2020, six per cent of the current workforce. The median number of staff unavailable for work was 34 and the mean was 147.
- 30 per cent of staff were unavailable through 'self-isolation (other)' and 34 per cent were unavailable due to 'Non-COVID sickness'.
- When asked whether individual services had enough staff to run them normally or not, the service most badly affected during the week ending 26 June was schools: over a quarter of single tier and county councils reported they were operating with severe disruption due to staffing numbers. Also badly affected were adults and children's services, with 26 per cent and 18 per cent of councils respectively reporting moderate disruption.
- When asked to assess the council overall, in terms of whether there are enough staff to run services normally or not, 47 per cent of councils report minor disruption.

Finally, councils were asked about the availability of personal protective equipment (PPE) and COVID-19 testing for staff. Eighty-eight per cent reported they had about the right amount of PPE they needed; while three per cent had less than they needed. Eighty-five per cent said all the staff who need testing can access it; only one per cent said it was available to some of their staff who need it.

Homelessness

Ombudsman highlights where councils can improve services to homeless people - Problems with the way councils are meeting new housing duties are making some homeless people's situation worse, the Local Government and Social Care Ombudsman has found. In a new report published this week, the Ombudsman examines the lessons that councils can learn from the first 50 cases it investigated under the Homelessness Reduction Act, introduced in 2018 [here].

They show more than 3.71 million (3,713,200) applications to the scheme and more than 3.4 million (3,459,700) applications concluded, up to the end of June 2020. Community centres, village halls, and other multi-use community facilities support a wide range of local activity. However, their communal nature also makes them places that are vulnerable to the spread of coronavirus (COVID-19).

This guidance is for those managing multi-use community facilities to prepare for re-opening when restrictions have lifted. It signposts to relevant guidance on a range of different activities that can take place in these spaces.

Many community facilities are also workplaces and those responsible for the premises should therefore be aware of their responsibilities as employers.

Health & Social Care

Public Health England COVID-19 surveillance summary - The latest Public Health England COVID-19 surveillance summary is available here (published Thursday 9 July 2020).

The report includes data from a variety of different sources: community, primary care, secondary care, virology, mortality and infection surveillance data. These combined data sources show a wider community picture including a breakdown by age, gender, ethnicity and geography and support the national response to the pandemic and assist regional stakeholders in local planning.
