Welcome to the latest LGA Apprenticeships Newsletter. This month, the deadline for the Local Government Apprentice of the Year is fast approaching (we can also now announce a special guest speaker) and we can share how we'll be supporting councils over the next few months with more information on our 2022 support programme. Apprenticeships Minister to speak at Local Government Apprentice of the Year event – but time is running out to book places!

News just in – we've secured the attendance of Apprenticeships and Skills Minister Alex Burghart MP to speak on Day 1 of the Local Government Apprentice of the Year event on 25 May. Apprentices taking part will have the opportunity to hear directly from him on his thoughts on apprenticeships and ask him questions.

This national event is open to all Level 2 and 3 Apprentices in local government including those who are currently apprentices as well as those that have recently qualified in the last twelve months.

Registration is open until Wednesday 4 May, so time is running out to book your apprentices' place(s). Places cost £149 per apprentice, with the charge purely to allow the organisers to recoup costs for developing, communicating and running the event on the day.

LGA Apprenticeships Support Offer 2022

We're pleased to let you know some more details of how we will be supporting councils with their Apprenticeship Programmes in 2022. As in previous years, we'll have a mix of support, tools and events that we hope will help you take your programmes forward. Over the next

two weeks we'll be sending out emails with full details on each of the elements outlined below, but we wanted to share our plans with you ahead of time so you know what to expect.

Webinars

As usual, we plan to have a full programme of webinars throughout the year. We've already delivered two this month – deep-dives into Social Care and Social Work apprenticeship programmes (see below for links to listen back to the webinars if you missed them) and plan to deliver at least another five webinars over the summer, covering topics like end-point assessment, low volume but high impact apprenticeships, schools and the updated funding rules. Look out for another email next week with more information about how you can book your place on each of these webinars.

Online National Events

Building on the success of our webinars, we will now be holding online national apprenticeship events for councils to join. Starting on an initial trial basis, we plan to host events in early June and September to bring together councils from all over the country to hear updates and share best practice. The events will last around 2.5 hours and will include updates from the LGA and guest speakers (ESFA are due to attend the first one in June), updates on the progress of relevant apprenticeship standards and the opportunity for discussion with other councils. Attendees will be split into groups for the second half of each session to explore ideas, tackle hot topics and provide feedback and views to the LGA on key issues and policy. Our first event will be on 8 June 1.30pm – 4pm and more information on our plans for this event and how to book your place will be emailed round early next week.

Practical Tools

We've always tried to develop useful tools, documents and templates for you to use in your programmes and this year will be no different. But rather than the ad-hoc release schedule that we have maintained the last few years, we will be releasing at least one new tool per month throughout the summer. Starting in May, with the publication of two short pathway guides and Apprenticeship A-Zs for Social Care and Social Work apprenticeships (as plugged in our recent webinars), we will be releasing new tools each month through to August. All tools will be available on the KHUB, and we'll let you know when they are available via each month's newsletter.

Apprenticeship MOTs

The Apprenticeship MOT has become a popular part of our support offer since we launched the process in 2019. The process – a mini-review of a council's apprenticeship programme – assesses council progress against the Apprenticeship Maturity Model, helps a council take stock of their programmes and offers advice and recommendations on where to focus effort to help the council improve. To date, 35 councils have gone through the process with us and they have proved to be a very popular part of our offer. We have another eight slots available to support councils this summer. In addition to the time we invest in developing the report for each participating council, we will also be providing an extra two days of consultancy support to assist each council that undergoes an MOT with elements highlighted in the MOT that it would like help with. All support is provided for free to councils as part of this programme. More information on available dates and how to apply for an MOT will be emailed to councils early next week.

End Point Assessment

The LGA has been working closely with South West Councils over the past few years to support the regional employer in setting itself up as an End Point Assessment Organisation. We were keen to ensure there was an EPAO that could deliver on key standards for the sector and respond to councils' needs. South West Councils has steadily built itself up, delivering End Point Assessment services for nine standards and are awaiting Ofqual Approval to deliver seven more. They are now the only EPAO for Revenues & Welfare Benefits Practitioner apprenticeship.

More than 30 councils across all nine English regions use their services already, and we want to bring their offer to a wider audience. Look out for more information from us soon, and a new page on the LGA website, showcasing South West Council's offer and how they can help you.

Level 4 Apprenticeship Standard on Data Protection and Information Governance

Many of you may have seen that there is a new Level 4 standard in development on Data Protection and Information Governance (it was in our last mapping newsletter and added to February's mapping tool). It's an apprenticeship that could have scope within councils. It should be ready in the not-too-distant future, so we thought it was worth sharing some information we have had from Jonathan Bourne MD of Damar Training. They are in the 'build phase' of their offer for this apprenticeship (with first enrolments expected in September), you can see high level info on their website:

One of the things they are doing as part of the design phase is to bring together a small employer reference group, to ensure that they fully understand and meet employer requirements – it would be great if a couple of LAs were involved in this to add your perspective.

IFATE Apprentice Panel Recruitment

Recruitment to join the Institute for Apprenticeships and Technical Education apprentice panel has now opened.
