National and Local implications of the Government's Levelling Up Agenda

THE KING'S SPEECH

This week, in his first King's Speech as monarch, and likely the last before the next UK general election, King Charles outlined the 21 laws that ministers intend to pass in the next year-long session of Parliament. These included:

- A Leasehold and Freehold Bill will ban leaseholds for new houses, but not new flats, and increase the standard lease extension period to 990 years
- The existing Renters (Reform) Bill will deliver a long-promised ban on "no-fault" evictions in England but this will only come into force after reforms to the court system
- An Automated Vehicles Bill will set a legal framework in Great Britain for self-driving cars
- A Tobacco and Vapes Bill will deliver plans for a phased ban on smoking, and introduce restrictions on the packaging and marketing of vapes
- A Rail Reform Bill creating a new body to oversee the railway in Great Britain is included, but only in draft form

HOMES FOR UKRAINE: PUBLIC ACCOUNTS COMMITTEE INQUIRY

The Homes for Ukraine Scheme was set up in March 2022, seeing 131,000 Ukrainians successfully supported to arrive in the UK with £2.1bn in funding.

A National Audit Office (NAO) report on the scheme found that, while Government gave early consideration to the risks of the scheme and put in place structures to manage them, there are still challenges to overcome, including the risk of homelessness. The report further found that the visas for the first Ukrainians to arrive under the scheme will expire in Spring 2025, and that it is unclear whether Government intends to extend existing three-year visas.

Based on the NAO report, the Public Accounts Committee is taking evidence on the number of applicants and sponsors, the funding provided and the challenges until Sunday 12 November 2023.

The Oral evidence session will take place on 23 November.
