## NATIONAL PAY NEGOTIATIONS

The full NJC Trade Union Side met earlier this week to discuss the National Employers' full and final pay offer, which they received on 23 Feb. No decision on the pay offer was reached at this meeting, but the unions did agree to reconvene within a few days of GMB's strike ballots closing.

UNISON announced recently it would not be taking any strike action and wished instead to, "...resolve this year's pay dispute and get that pay increase in [its members] pockets as soon as possible."

Unite is currently engaged in industrial action in a small number of councils, and GMB is conducting industrial action ballots, targeted at some councils and schools, which close on 24 Oct.

EMC will continue to update members on any developments as they arise.

#### ILM LEVEL 5 AWARD IN LEADERSHIP AND MANAGEMENT

East Midlands Councils, in partnership with Challenge Training, are providing an opportunity for current and aspiring middle managers to extend their skills to get the best from themselves, their team and their organisation in times of change and continuous improvement.

This five-day course, split over four face-to-face days and two online half-days, is designed to encourage participants to assess their own leadership capability and performance, and to provide confidence and competence within their role to create a culture of continuous improvement where teams and individuals feel valued and engaged.



### PUBLIC INVESTMENT IN THE EAST MIDLANDS

The Treasury publishes an annual Public Expenditure Statistical Analysis (PESA) every July on where public money (capital and revenue) is spent and on what. There are a number of evident trends:

- Economic Growth funding and transport spend per head has been very significantly below the UK average level for a number of 20 years.
- Transport expenditure per head in the East Midlands has declined to just 60% of the UK average for 2021/22, the lowest level of any UK region or nation.
- The disparity in levels of investment spend per head between the East Midlands (£394) and the West Midlands (£688) has significantly widened. This is likely due to large-scale infrastructure programmes including HS2.
- If the region was funded at a level equivalent to the UK average, a not unrealistic target, the East Midlands would have an extra £1.28bn a year to spend on transport investment and services.

On rail spending specifically, all regions, with the exception of the North West and West Midlands, have seen a reduction in expenditure on rail from 2020-21 levels. The East Midlands has the 2<sup>nd</sup> lowest level of rail investment per head nationally, and only 40% of that of the West Midlands.

This is important context for the levelling up ambition of the region and has a number of policy implications going forward. Read more in EMC's latest Executive Board Report:
