## **AUTUMN STATEMENT: IN THE EAST MIDLANDS**

On Wednesday 22 November, Chancellor Jeremy Hunt delivered his Autumn Statement, covering a variety of areas, including changes to welfare, tax cuts and support for British businesses.

In the East Midlands, we saw announcements for a new investment zone, as well as a deal to bring devolution to Greater Lincolnshire.

In the statement, the Government said the East Midlands Investment Zone would focus on green industries and advanced manufacturing and help leverage £383 million in private investment, as well as supporting 4,200 jobs in the region over the next 10 years.

It will cover parts of Nottinghamshire, Derby and Derbyshire, with anchor investment from Rolls Royce in Derby and engineering and construction giant Laing O'Rourke valued at £9.3 million

In the East of the region, plans for devolution for Greater Lincolnshire could see the formation of a new Mayoral Combined County Authority (MCCA), supporting the area's 1.1 million residents over 30 years. Read the full Autumn Statement:

## NET MIGRATION INTO THE UK HITS RECORD HIGH

Net migration hit a record-breaking 745,000 in 2022, according to revised figures from the Office for National Statistics.

In its last figures released in May, the ONS said the number for last year was 606,000 - then deemed a record high. But looking at the numbers again, the organisation now says the actual figure was almost 140,000 higher than first thought.

The ONS has highlighted a trend indicating a slowing of immigration coupled with increasing emigration. The office also referenced changes in behaviour such as international students staying longer and moving onto work or graduate visas, and people moving to the UK with their families to fill skilled jobs in health and care sectors.

They also referenced a slowing of figures from Hong Kong British Nationals and Ukrainians.
