



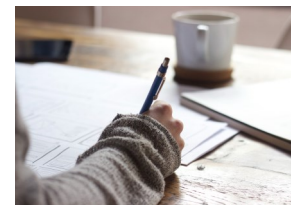

UPDATE ON NATIONAL PAY NEGOTIATIONS

This week GMB confirmed that it will conduct disaggregated industrial action ballots of its NJC 'Green Book' and JNC Craft 'Red Book' members in some councils and schools in England, Wales and Northern Ireland. The organisations to be targeted for strike ballots will be notified in the next few weeks.

UNISON's strike ballots closed on 4 July, and Unite's ballot closes today. We expect both unions to signal their intentions early next month.

EMC will continue to keep local authorities updated with developments on the national negotiations and ballots as they arise .

RAIL TICKET OFFICE CLOSURE CONSULTATION EXTENDED

The consultation into the plan to close hundreds of ticket offices in England has been extended until 1 September.

Organisers of the consultation said some train companies did not provide accessible formats, preventing people from being able to respond to plans.

The 21-day period for passengers to share their views was due to end on Wednesday, but the Rail Delivery Group say it has listened to feedback and has extended the consultation period by almost six weeks "to give as many people as possible a chance to take part".

More than 170,000 responses have been received to date, according to watchdogs Transport Focus and London TravelWatch.
