Our face-to-face <u>East Midlands Challenge</u> event will also be returning this March, offering a fantastic opportunity for aspiring leaders to gain exposure to issues outside of their normal work, giving them a taste of what senior management is really like.

Over the year, as new policies were brought forward for housing and planning, and continued structural changes to the rail industry progressed, including the refresh of the HS2 growth strategy, colleagues have had to adapt quickly to support vital transport networks.

£32.9 million to create national network of active travel experts



Funding for local authorities to train engineers and planners to conduct highquality engagement and consultation sessions with local communities.

This week, Active Travel Minister Jesse Norman has announced a £32.9 million investment to create a national network of experts to work with communities, enhance high streets and make places truly walkable and cyclable for everyone.

The fund aims to drive thousands of well thought-through local plans, co-created with the communities who will use them.

The Capability Fund will support local authorities across the country to train and retain local engineers and planners, creating a skilled active travel workforce able to collaborate effectively with local communities and conduct high-quality engagement and consultation sessions.

As well as enabling local authorities to hire and retain skilled professionals, this multi-million-pound investment will deliver specialised training, driving up skills and ensuring consistent, high-quality schemes can be delivered across England.

The funding will also be used to give travel choice to a wider demographic by engaging under-represented groups, provide cycle training and bike rental schemes.

£2 bus tickets for thousands of routes until end of March

Starting this week (1st January 23) over 130 bus operators outside of London will charge no more than £2 for their single tickets across over 4,600 routes, helping families, commuters and other passengers save money on travel.

The Government hopes the initiative will encourage people to get back on the bus to help the industry continue its recovery from the pandemic, as well as reduce CO2 emissions and tackle congestion by taking an estimated 2 million cars off the road.

HS2 opens recruitment for 40 graduate jobs

Last month, HS2 Ltd launched its search for 40 talented graduates to join its 2023 programme.

With a two-decade long construction programme ahead, HS2 is bolstering its technical services directorate and offering engineering graduates the chance to join the teams charged with delivering the stations, tunnels and viaducts along the route of the new railway. There will be further opportunities in HS2's Environment, Hybrid Bill, Project Management, Procurement and Commercial teams.

Applications for HS2's 2023 graduate recruitment programme will close on 22nd January 2023.

Number of defibrillators to be increased with new funding

The number of life-saving defibrillators will be increased with new £1million fund.

The Department of Health and Social Care will invest the funding through an independent partner who will manage grant applications from bidding organisations. Those selected will be asked to match the funding they receive



fully or partially, potentially doubling the number of new defibrillators created by the fund.

Applicants will also be asked to demonstrate that defibrillators will be placed in areas where they are most needed, such as places with high footfall, vulnerable people, rural areas, or due to the nature of activity at the site.

Examples could include town halls, community centres, local shops, post offices and local parks, to ensure that defibrillators are evenly spread throughout communities and easily accessible if someone is experiencing an unexpected cardiac arrest.

Cost of Living

Millions of low-income households to get new Cost of Living Payments from Spring 2023



This week, the Department for Work and Pensions (DWP) has announced more detail on the payment schedule for the next round of cost of living support unveiled in the Chancellor's Autumn Statement, building on payments made to over eight million people in 2022.

The new £900 cash boost for over eight million eligible means-tested benefits claimants, including those on Universal Credit, Pension Credit and tax credits, starts in Spring and will go direct to bank accounts in three payments over the course of the financial year. There will also be a separate £150 for over six million disabled people and £300 for over eight million

pensioners on top of their Winter Fuel Payments.

Levelling-up and Regeneration Bill Consultation

On 22 December, DLUHC launched a consultation to seek views on the department's proposed approach to updating to the National Planning Policy Framework.

DLUHC is also seeking views on preparing National Development Management Policies, how we might develop policy to support levelling up, and how national planning policy is currently accessed by users.

UK subsidy control regime commenced today

The UK subsidy control regime began earlier this week. It enables public authorities, including councils and devolved administrations, to give subsidies that are tailored to local needs, and that drive economic growth while minimising distortion to UK competition and protecting international obligations.

Subsidies are financial assistance – such as grants, loans or tax credits – that authorities can offer to companies to support policies that are in the public interest, to address a market failure or equity concern.
