EMC Annual General Meeting - EMC Annual Report

Today the EMC Annual General meeting took place at Nottinghamshire County Council, the full papers are available <u>here.</u>

Cllr Martin Hill, Chair of East Midlands Councils and Leader of Lincolnshire County Council presented the East Midlands Councils Annual Report for 2021-22 [available <u>here]</u>. This Annual Report is a summary of our work over the past 12 months and enables us to account to our membership for what we have done on your behalf in meeting your agreed priorities. It covers the range of EMC's programmes and services, including proposals for greater investment and infrastructure funds, our work on HS2 and the Integrated Rail Plan (IRP), providing focused member and officer development programmes and our role as the Regional Employers' Organisation; as well as taking forward the management of important refugee and asylum resettlement programmes

We're especially pleased that all member councils accessed at least one of these discounted services during 2021/22, with EMC delivering savings on behalf of its member councils estimated to be £562,000.

We remain grateful to EMC staff, councillors and officers across the region for their efforts and on-going engagement. We look forward to continuing to work with colleagues across the East Midlands during 2022/23.

Infrastructure, Planning & Housing

Levelling-Up Committee examines planning reform concerns - On Monday 18 July, housing, planning and conservation experts will be questioned by the Levelling Up, Housing and Communities (LUHC) Committee on the Government's Levelling Up, Housing and Regeneration Bill.

The LUHC Committee will question representatives from National Housing Federation, British Property Federation, Council for the Protection of Rural England, Natural England, Design Council, and Localis.

The cross-party group of MPs are likely to examine concerns around claims the Bill will lead to a centralisation of the planning system and raise questions concerning the Government's planning proposals and how effective they are likely to be in making progress on the levelling-up agenda [details <u>here]</u>.

Derelict sites to be transformed into new homes as new brownfield fund opens

- Over 17,000 new homes will be created with £180 million new brownfield fund
- Councils will be able to bid for first £40 million from today, further £140 million allocated over next 2 years
- Builds on success of previous £77 million fund to support the regeneration of unused brownfield sites

Councils will be able to apply for a share of the new £180 million Brownfield Land Release Fund 2, which will help to transform disused urban areas into 17,600 new homes and create around 54,000 jobs over the next 4 years.

An initial £40 million is available to support local regeneration projects, releasing council land for around 4,000 new homes (and creating 12,400 jobs). The move will boost local economies and help thousands of young people and families into homeownership. The remaining £140 million of the Brownfield Land Release Fund 2 will be made available to councils over the next 2 years.

Bids will be assessed on a number of gateway criteria including: market failure; deliverability; and value for money.

The prioritisation of bids will comprise an assessment of the strategic case, innovation and consideration of the bid's ability to meet the council's Public Sector Equality Duty, combined with a place-based metric [details <u>here]</u>.

One Public Estate: Brownfield Land Release Fund details: July 2022 - Up to £180 million Brownfield Land Release Fund 2 (BLRF2) capital grant funding is available to all English councils over a three-year period to support the release of council-owned brownfield land for housing [details <u>here]</u>.

Midland Connect



A1 Upgrade: Nearly three quarters support upgrading A1/A52 in Grantham - Residents in Lincolnshire and Newark have given plans for an upgrade to the A1/A52 their overwhelming support. The research, done by YouGov for Midlands Connect, shows that nearly three quarters (72%) support the plans to upgrade the A1/A52 junction, with 55% of those surveyed saying they 'strongly support' the upgrades. Over 40% think the project will reduce journey times for them and their families, once

they are completed.

Furthermore, nearly three quarters (74%) believe the project will lead to wider benefits including less congestion and reduced traffic in residential areas.

Over one in three respondents also said the plans (35%) would have a 'significant' impact on reducing road accidents/ traffic collisions.

Midlands Connect and Lincolnshire County Council have proposed the upgrades to the government. In its recent Strategic Transport Plan Midlands Connect dubbed the scheme one its key projects for investment in the next 10-15 years.

The partnership want Government to award the project support as part of its Road Investment Strategy 3 (RIS3). If successful, this could mean that National Highways is given funding to deliver the improvements as early as 2025.

Nottinghamshire County Council chooses new chief executive - Adrian Smith has been selected by the Senior Staffing Committee as the next Chief Executive at Nottinghamshire County Council, subject to approval of the County Council at the Full Council meeting on 22nd September. Adrian, is currently the authority's Deputy Chief Executive and Corporate Director for Place, responsible for economic development and the county's highways, transport and communities [details <u>here].</u>
