Scrutiny: Reset and Recovery, 10 Nov 2020

EMC is offering Councillor and Officers involved with Scrutiny the opportunity to join an interactive virtual workshop 'Scrutiny: Rest and Recovery'. This virtual workshop has been designed to focus on the role of scrutiny in the 'reset and recovery' period. For details of the workshop visit [here](#).

Local government has changed significantly in order to adapt to the COVID-19 pandemic. Functions, finances and political management arrangements have been re-shaped since March 2020. Scrutiny has also been impacted by COVID. This virtual workshop has been designed to focus on the role of scrutiny in the 'reset and recovery' period.

It will examine a range of related issues:

- reviewing the impact on scrutiny functions across the region, including how scrutiny members and officers have responded
- highlighting best practice in working remotely and through virtual platforms
- identifying learning from scrutiny reviews of council responses to COVID-19
- considering the role that scrutiny can play in the recovery planning period
- outside of COVID-19, identifying emerging and re-emergent priority topics for scrutiny to examine, for example, scrutiny of climate change and scrutiny of re-organisation

In particular, the workshop will focus on how the recovery stage is developing and how scrutiny needs to play a part in debates over growing financial and budgetary pressures and fundamental re-prioritisation processes.

EMC News

EMC held its AGM on Friday 9th October. The meeting was attended by Rt Hon Robert Jenrick, Secretary of State, MHCLG who responded to a range of questions including the response to Covid-19, devolution and structural reform, the Planning White Paper proposals and delivery pressures of the sector.

Subsequent discussion focused on economic growth and investment, and the renewed efforts to secure better infrastructure and to maximise opportunities from the levelling up agenda. Members also agreed that EMC should respond on behalf of the region to the Planning White Paper proposals. A draft will be shared with Members in advance of formally responding to the consultation.

Cllr Martin Hill (Leader, Lincolnshire County Council), Cllr David Mellen (Leader, Nottingham City Council) and Cllr Jonathan Morgan (Leader, Charnwood Borough Council) were confirmed as Chairs and Vice-Chairs respectively for the coming year. Cllr Ivan Ould was also thanked by the membership for his contributions over a number of years, most latterly as Chair of the Regional Migration Board.

Midlands Engine Economic Impact of Covid-19, Edition 9:14 September (Skills deep dive summary) -

This report is produced by the Midlands Engine Economic Observatory which is a partnership commissioned by the Midlands Engine including Black Country Consortium's Economic Intelligence Unit, Nottingham Trent University and WM REDI. This monitor pulls together information across regional partners to understand the impacts of Covid19 on the economy – at a sub national level, across the Midlands Engine geography. Where possible it will utilise all forms of quantitative and qualitative intelligence. However we urge caution in the use of the contents as this is an emerging situation. Migration, Asylum Support and Refugee Resettlement

EUSS: Updated local authority toolkit and Grant Funded Network Launch - The Home Office has produced and published new resources for the [local authority toolkit](#) to promote the EU Settlement Scheme. These resources include a factsheet and leaflet for with key information for EEA Nationals.

New £4.5 million grant funding has been awarded to 72 organisations including local authorities, local government associations and voluntary and community sector organisations – list of organisations is available to view [here](#).

Reminder that the deadline for applying to EUSS is 30th June 2021 for those who were resident in the UK by 31st December 2020. So far over 4 million people have applied.

Employers' Information

Exit Pay Cap Update - The legislation to implement the £95k cap on exit payments in the public sector has completed the Parliamentary process and was signed into law last night meaning the regulations, and therefore the cap, come into force on 4 November 2020. As yet neither the Guidance nor Directions to accompany the regulations have been published. This means there is no further information regarding the waiver process or provision for current exits in progress. MHCLG's consultation on changes to the Local Government Pension Scheme rules required to accommodate the £95k cap is ongoing and will not conclude before the cap comes into effect. With colleagues at the LGA, EMC are raising our concerns about the implementation of this legislation, including the treatment of exits currently in process, with MHCLG and HM Treasury. EMC will provide you with any further updates when more information is known.

Kickstart Scheme, Expressions of Interest - As part of the Government's Plan for Jobs, the Kickstart Scheme provides funding to employers to create new 6-month job placements for young people. To access the scheme, an employer must provide 30 placements which is likely to be a challenge for many local authorities.

To overcome this potential barrier, EMC are looking to co-ordinate Kickstart applications on behalf of Authorities in the East Midlands and become a representative organisation for the Scheme. Therefore, we are collecting expressions of interest from any Authority that would like to participate in the Scheme and become part of this group so that the 30 placements can be provided through our collective offer.
