

**EMC Events for Councillors** and Officers

#### **Transport for the East Midlands**

The Transport for the East Midlands (TfEM) Board met on the 14 June 2021 chaired by Sir Peter Soulsby. The Board considered the implications of the Government's Rail White Paper or the East Midlands, and a presentation from Highways England on the process for determining investment priorities for RIS3 (2025-30). The Board also discussed the reasons behind the recent drop in performance in EMR regional service following the introduction of the May timetable, and proposals by EMR to introduce a temporary regional timetable from 19 June to give time for the problems to be fixed. EMR Inter-City and electric Connect services from Corby will be unaffected. For further information on TfEM visit here.

HS2 Executive Board - The HS2 Executive Board will meet for the first after the May elections on the 24 of June to consider an update on work to influence the Government's forthcoming Integrated Rail Plan.

East Midlands Strategic Migration Board - The Regional Migration Board considered the current situation along the south coast with unaccompanied asylum-seeking children (UASC) crossing the Channel in small boats, and the national request for assistance for local authorities most affected. The government's recent announcement of the launch of the new UASC National Transfer Scheme was also discussed.

## Migration, Asylum Support and Refugee Resettlement

**EU Settlement Scheme applications exceed 5.6 million -** Over 5.6 million applications have been made to the EU Settlement Scheme (EUSS) according to the latest monthly statistics, with 20 days to go before the 30 June 2021 deadline.

The figures show that, up to the end of May 2021:

- 5.61 million applications were received.
- 5.27 million applications were concluded.
- Across the UK, more than 5 million applications were received from England, 276,600 applications from Scotland,
   92,700 applications from Wales and 92,000 received from Northern Ireland.
- 2.75 million (52%) were granted settled status and 2.27 million (43%) were granted pre-settled status, totalling more than 5 million grants of status.
- Of the remaining applications, 72,100 (1%) received a withdrawn or void outcome, 74,900 (1%) were invalid and 94,000 (2%) were refused.

Digital Status - From 1 July 2021, EU, EEA and Swiss citizens and their family members granted status under the EU Settlement Scheme will need to evidence their rights in the UK with their digital immigration status, rather than their passport or ID card. For example, they may need to do this when applying for a job or when renting a property. The Home Office have published guide for EU, EEA and Swiss citizens on viewing and proving their immigration status for EU, EEA and Swiss citizens on viewing and proving their immigration status (eVisa). The guide explains how people can view and prove their immigration status, update their details, what they should expect when crossing the UK border and how to get help accessing their immigration status.

**Local Voting Rights for EU Citizens Living in the UK (Policy Paper)** - EU citizens' voting and candidacy rights in local elections need to be updated to reflect our new relationship with the EU. For details of the proposed changes visit <u>here.</u>

#### **Economic Development**

**DCMS Study on Regional Digital Ecosystems** - The Department for Digital, Culture, Media and Sport (DCMS) is looking to assess the UK's regional digital ecosystems and their ability to generate economic prosperity and growth. The sector has the ability to increase prosperity in regional economies across the UK, generating higher than average GVA and creating high-earning and resilient jobs. This project aims to help DCMS to build its evidence base on regional digital ecosystems and to explore tailored interventions to promote digital prosperity.

The project is in development and colleagues in Local Government are invited to 'sense check' the initial findings (regional findings are included on the attachment) and provide views on the success and challenges of the digital ecosystem in each region. **Eviction protection extended for businesses most in need** - Businesses that have had to remain closed during the pandemic and are unable to pay rent on their commercial property will continue to be protected from eviction, giving them the breathing space they need and helping to protect jobs, the government has announced this week [here].

Committee examines global approaches to sustaining high streets and town centres - The Housing, Communities and Local Government Committee continues its inquiry into supporting our high streets after covid-19 on Thursday 10 June as it examines examples of best practice from across the globe. The session investigated the global outlook for high streets and town centres. It heard examples of best practice in protecting high streets from the health and economic impacts of pandemics, including previous cases such as SARs. The Committee also examined what lessons UK town centres can learn from approaches taken in other countries towards housing, transport and climate change [ here].

#### **Health & Social Care**



Everyone working in care homes to be fully vaccinated under new law to protect residents - People working in CQC-registered care homes will need to be fully COVID-19 vaccinated with both doses.

The new legislation means from October – subject to Parliamentary approval and a subsequent 16-week grace period – anyone working in a CQC-registered care home in England for residents

requiring nursing or personal care must have 2 doses of a COVID-19 vaccine unless they have a medical exemption. It will apply to all workers employed directly by the care home or care home provider (on a full-time or part-time basis), those employed by an agency and deployed by the care home, and volunteers deployed in the care home. Those coming into care homes to do other work, for example healthcare workers, tradespeople, hairdressers and beauticians, and CQC inspectors will also have to follow the new regulations, unless they have a medical exemption [details here].

**Public Accounts Committee 'No more broken commitments on care: underfunded, unclear, urgently needs reform'** - In its report published this week, the Public Accounts Committee says the pandemic's "devastating impact on the care sector" has emphasised that "care is not properly funded, lacks transparency and urgently needs reform." to access the report visit <a href="https://example.com/hereita/
