Levelling Up Fund—Round Two

This week, the Department of Levelling Up, Housing and Communities announced the new areas which will be awarded funding from round two of the Levelling Up Fund.

In the East Midlands, 11 projects have received a total of £176,870,348, which is 8.5 per cent of the £2.1 billion fund. These include:

Ukraine updated guidance

This week, the Department of Levelling Up, Housing, and Communities published updated guidance for the Homes for Ukraine scheme to reflect recent announcements and changes.

The guidance has specific sections for three audiences:

Ministers questioned over refugee funding cuts

The Levelling Up, Housing and Communities Committee this week questioned ministers over what assessments had been made before reducing the funding for Ukrainian refugees from £10,500 per person to £5,900.

Despite the cuts to the tariff, the Government has provided a one-off pot worth £150m to tackle homelessness and a £500m fund to provide up to 4,000 homes by 2024, including housing for Afghan and Ukrainian refugees.

The committee heard that homes would pass to general housing stock after refugees have returned to Ukraine.

Hosing minister, Felicity Buchan, also confirmed the Government was no longer looking at aligning the Homes for Ukraine and family visa schemes.

Local communities to get £750,000 for Windrush 75th anniversary celebrations

Applications for the Windrush Day Grant Scheme are now open. Community groups, charities and councils will now be able to bid for their share of the £750,000 pot of funding to celebrate the 75th anniversary of the arrival of the Windrush community in their local areas.

Each area can bid for up to £50,000 to fund celebratory parades, educational resources, arts and sporting projects, providing they are focused on the contribution of the Windrush generation and their descendants.

New plan for smart electric vehicle (EV) charging could save consumers up to £1000 a year

This week, the department for Business Energy and Industrial Strategy published its 'Electric Vehicle Smart Charging Action Plan', which sets out steps being taken to seize on the significant potential of smart charging and make it the preferred method of long duration charging by 2025.

Smart charging harnesses the potential of energy use data and the latest energy innovations to deliver significant benefits for consumers. This includes allowing motorists to charge electric vehicles when electricity is cheaper or cleaner, allowing consumers to power their home using electricity stored in their electric vehicle, or even sell it back to the grid for profit.

It is expected high mileage motorists could save up to £1,000 a year through smarter charging.

£60 million brownfield development fund announced

Disused brownfield sites across England will be regenerated to deliver thousands of new homes and jobs, the Department for Levelling Up, Housing and Communities announced this week.

Councils across England will now be able to bid for a share of £60 million from the Brownfield Land Release Fund 2, which will help to bring neglected urban areas back into use, support regeneration projects and boost local economies.

The funding is set to deliver 5,800 new homes by March 2027, create around 18,000 new jobs in the housing and construction sector, while helping thousands of first-time buyers into homeownership.

The full brownfield fund will deliver 17,600 new homes and 56,000 skilled new jobs over the next 4 years, helping to transform communities and level up the country.
