Bidding opens again for £4.8 billion levelling up fund -Applications for the second round of the government's Levelling Up Fund now open until 2 August [details <u>here</u>].

Housing

Private renters' inquiry launched by Levelling Up Committee - The Levelling Up, Housing and Communities (LUHC) Committee has launched an inquiry into Reforming the Private Rented Sector, examining the Government's proposals set out in its recent White Paper, <u>A Fairer Private Rented Sector</u>.

The inquiry will scrutinise the Government's plans to, among other things: introduce a decent homes standard for the private rented sector; reform the system of tenancies and abolish no-fault evictions; reform the grounds on which landlords can take possession of their properties; and better protect tenants from unfair rent increases [details <u>here]</u>.

Social housing tenants' complaints of 'uninhabitable homes' must be addressed - The condition of some social housing in England has deteriorated so badly as to be unfit for human habitation, and social housing providers must significantly improve their complaint handling process, says the cross-party Levelling Up, Housing and Communities Committee in a report published this week. The Committee's Regulation of Social Housing report addresses a series of issues relating to the supply, quality and regulation of social housing in England. Social housing is housing rented at below-market rates by housing associations, local authorities and private providers [details <u>here].</u>

Infrastructure, Planning & Housing

Hard to decarbonise social homes - This report, commissioned by the National Housing Federation and the Local Government Association, examines the decarbonisation of social homes and why some are harder to decarbonise than others. The report explore the characteristics and constraints of the hardest to decarbonise homes and examine how policy changes could reduce the risk of homes being disposed of when there is potential for them to be decarbonised [details <u>here]</u>.

Government sets out plan to reduce water pollution - New plans to help safeguard England's precious protected sites by driving down nutrient pollution and allowing for the construction of sustainable new homes for families across the country were announced by the Government this week [details <u>here]</u>.

<u>One Public Estate (OPE) programme</u> has made £180 million of capital grant funding available to English councils through the newly launched <u>Brownfield Land Release Fund (BRLF2)</u>. The funding provides capital grants over a three-year period to remove constraints on council-owned brownfield land, tackling the challenges and complexities that make them unviable, and allowing them to be released for new homes. The first application window is open now until 23.59 on 19 August. For more information visit <u>here.</u>

Asylum Support and Refugee Resettlement

Homes for Ukraine, latest regional data - The latest regional data on Homes for Ukraine. This data shows that over 4,200 people have arrived in the East Midlands. Ukraine Sponsorship Scheme: Visa data by country, upper and lower tier local authority - available from <u>here</u>. Regional position as at 19/07/22 (increase over previous week/fortnight position reflected in parentheses):

- Visa applications: 6,474 (+112/+284)
- Visas issued: 5,794 (+105/+298)
- Arrivals: 4,278 (+114/+280)

Support for Ukrainian refugees – Clive Betts, Chair of the Levelling Up, Housing and Communities (LUHC) Committee has written to Lord Harrington, Minister for Refugees, regarding the Government's support for Ukrainian refugees and asking for an update on the Government's progress in enabling people to switch from the family scheme to the Homes for Ukraine scheme [details <u>here]</u>.

Piloting devolved decision-making for child victims of modern slavery, 2 August 2022, 2.00pm - the 10 local authority pilots who successfully bid to take over devolved decision making for potential child victims of modern slavery in their areas have now been operational for just over a year. Following positive interim findings including significantly swifter decisions, the Home Office has confirmed that all pilots have been extended to run to 2023. It will also be expanding the pilot to a further 10 sites, with bids expected to be invited in September, and go live in January 2023. Any local authority responsible for children's social care will be eligible to bid as an individual site or as part of a consortium. To support councils interested about the pilot and/or are considering bidding, the LGA is hosting a webinar where delegates will hear from two of the existing pilots about their experience, as well as from the Home Office about the mechanics of applying.
