# Levelling Up and Regeneration Bill vote faces delay

The Government has delayed a vote this week on an important piece of legislation for devolution, combined authorities and for dealing with regional inequalities following a threatened rebellion by Tory MPs. Some 47 Conservative MPs have signed an amendment to the Levelling Up Bill, which would ban mandatory housing targets in England. The Levelling Up Bill is a piece of legislation intended to deal with regional inequalities, but also contains a number of planning measures. The bill, which is at the report stage, was debated in the House of Commons

earlier this week and a further debate was due to take place on Monday.

This was expected to be followed by a vote on amendments. But a spokesperson for the Department for Levelling Up, Housing and Communities said that "the vote due on Monday has been delayed; a new date will be set depending on parliamentary time".

In addition to banning mandatory housing targets, the amendment to the bill would also scrap the current system under which local councils have to maintain a rolling five-year stock of land for future development.

Other amendments tabled by rebels would create stricter time-limits for developers granted planning permission to start building.

# Building safety levy moves a step closer

Proposals for how developers would pay to fix unsafe buildings have been set out this week by the government as it moves a step closer to imposing its new Building Safety Levy.

The government has now begun consulting developers and other interested parties on the plans, which will see an estimated £3 billion collected over the next 10 years.

Under the proposals drawn by the Department for Levelling Up, Housing and Communities, developers of residential buildings, regardless of their height, will have to pay the levy contribution as part of the building control process.

This will mean that unless the levy is paid, a developer could not move on to the next stage of the building process, which could lead to project delays and impact future revenues.

The consultation seeks views on the delivery of the Levy, including how it will work, what the rates will be, who must pay, what sanctions and enforcement will apply, and who is responsible for collecting the levy.

The consultation will be open for 10 working weeks from 22 November 2022 and seeks the views of all interested parties, especially developers of all sizes, building control professionals and local authorities.

The Autumn Finance Bill 2022 was published earlier this week, legislating for tax changes announced by the Chancellor of the Exchequer, Rt Hon Jeremy Hunt MP, as part of last week's Autumn Statement.


The Autumn Finance Bill 2022 had its first reading on Tuesday and will follow the normal legislative path through Parliament.

The main Spring Finance Bill 2023 will follow the spring Budget in the usual way, for remaining tax measures ahead of April 2023.

#### Migration to UK rises to record 504,000 with Ukraine and Hong Kong schemes



The end of lockdown restrictions in the UK, the first full period following transition from the EU, and world events including the war in Ukraine, the new visa route for Hong Kong British Nationals (Overseas) and resettlement of Afghans have all contributed to record levels of immigration.

Yesterday, the Office for National Statistics released data on Long-term international migration, showing record levels of international immigration in the year to June 2022 with 504,000 more people arriving into the UK than departing in the past year.

The Independent Chief Inspector invites anyone with knowledge or experience of applying to the schemes to submit evidence to inform this inspection and welcomes views on what is working well and what could be improved. #### Jenrick vows to improve relationship with sector on asylum

Immigration minister Robert Jenrick has told the sector the Home Office is 'very keen to improve the relationship' with local government amid the asylum crisis.

Speaking at a webinar on accommodation for asylum seekers, Mr Jenrick admitted hotels had been booked 'without the kind of engagement I would expect' and said he hoped things would improve.

He conceded a number of councils had 'legitimate concerns' about the use of hotels but explained the Home Office's hands had been tied by the 'emergency situation'.

He pledged councils would be given 24 hours' notice about the use of hotels and said there would be 'proper engagement with local authorities to select the right locations' in future.

Mr Jenrick told council leaders and chief executives: 'We haven't got this right in every case so far.

'The Home Office is very keen to improve the relationship [with councils].'
