

HEALTH NEWS

Long-term strategy launched to fix children's social care

The Government has announced plans to transform children's social care, putting families at the heart of reform.

Backed by £200 million over the next two years, a new, ambitious and wide-ranging Children's Social Care Implementation Strategy will transform the current care system to focus on more early support for families, reducing the need for crisis response at a later stage.

NHS to expand services to keep vulnerable out of hospital

Tens of thousands of elderly and vulnerable people will receive tailored support at home as part of a new NHS plan to improve waiting times for emergency care.

It comes as the government and the NHS publish a new urgent and emergency care plan, following increasing demand on NHS services.

Under the plans, community services including falls and frailty teams will be scaled up, with up to 50,000 people a month supported by clinicians at home in high-tech 'virtual wards'. Urgent community response teams will also be scaled up to provide more patients with support at home within 2 hours, in recognition of the pressures facing A&E.

£53 million cash boost to improve housing support for drug and alcohol recovery

People in alcohol and drug recovery will soon have access to housing support, helping to break the cycle of addiction and improve health outcomes.

Up to £53 million will be allocated to 28 local authorities across all regions of England with the greatest need.

The funding will allow for local authorities to create new housing support schemes tailored to meet local need.

New research hub to help tackle decarbonisation and improve transport resilience

A new research hub is being launched to boost innovative measures to decarbonise and improve transport, as the country works towards its net zero goals.

Decarbonisation Minister Jesse Norman has announced applications are now open for organisations to host the new hub, with the government pledging £10 million in funding for the centre, which will establish a UK centre of excellence for transport innovation.

Local Resilience Forum (LRF) 2021/22 funding pilot evaluation

This week, DLUHC published findings from the evaluation of the Local Resilience Forum (LRF) funding pilot.

In 2021, DLUHC provided £7.5 million of funding to LRFs for one year as a pilot project to improve LRF capacity and capability, and to collect evidence on the efficacy, challenges and opportunities of the government providing direct funding to LRFs.

The pilot was evaluated to assess the outcomes, additionality, and value for money of the funding.

The evaluation shows that the pilot was well received by LRFs and has allowed them to take significant steps towards delivering new capacity and capability to support focused work on delivering improvements to specific capabilities and nationally and locally defined priorities.

HOUSING AND INFRASTRUCTURE NEWS

Consultation: Changes to the building control profession and the building control process for approved inspectors

This week, DLUHC published a consultation which sets out for changes to the building control profession and the building control process for approved inspectors (in future to be known as registered building control approvers).

This consultation sets out the detailed requirements needed to implement the changes brought about by the Building Safety Act 2022. The consultation closes at 11:45pm on 14 March.

Regulator of Social Housing publishes initial findings on damp and mould in social housing

This week, the Regulator of Social Housing (RSH) published its initial findings on damp and mould in England's social housing.

Following the coroner's report into the death of Awaab Ishak in Rochdale, the regulator asked all larger social landlords to submit evidence about the extent of damp and mould in tenants' homes and their approach to tackling it. This covered councils and housing associations who together own and manage over four million homes in England.

Six weeks for developers to sign contract to fix unsafe buildings

Developers have received legally binding contracts that will commit them to pay to repair unsafe buildings.

The government has set a six-week deadline for developers to sign the legal agreements and is warning that companies who fail to sign and comply with the terms of the contract will face significant consequences.

Legislation will be brought forward in the spring giving the Secretary of State powers to prevent developers from operating freely in the housing market if they fail to sign and comply with the remediation contract.

MPs back plans to enforce minimum service levels during strikes

MPs have backed plans aimed at enforcing minimum service levels for some sectors during strikes.

Under the bill, some employees, including in the rail industry and emergency services, would be required to work during industrial action - and could be sacked if they refuse.

The bill passed by 315 votes to 246 but will face further scrutiny in the House of Lords before it becomes law.

Hundreds of thousands more workers to receive job support boost in spring

New regulations which came into force this week mean more than 120,000 working people on Universal Credit across Great Britain will receive a job support boost this spring.
