## FULL SPEED AHEAD: BRINGING HIGH SPEED-RAIL TO THE EAST MIDLANDS

On Monday, Transport for the East Midlands launched its latest publication, Full Speed Ahead: bringing high speed-rail to the East Midlands, which lays out the 'overwhelming' case to deliver high-speed rail to the East Midlands.

The report outlines the benefits of bringing HS2 to the East Midlands and Sheffield as proposed in the Government's Integrated Rail Plan for the North and Midlands (IRP). The arrival of HS2 in the East Midlands, integrated with other projects such as Midlands Rail Hub and Midland Main Line electrification will bring cities and towns in the East Midlands closer to each other and to centres such as London and Birmingham.

The launch event was held alongside Midlands Connect in Derby, where HS2 and Rail Minister Huw Merriman MP made a key note speech, while local MPs Amanda Solloway MP and Ben Bradley MP, and key business chiefs and senior politicians, also spoke on the many benefits high -speed rail to the midlands offers.

## **UPCOMING EMC TRAINING**

### TRANSITIONING AFGHAN FAMILIES FROM TEMPORARY ACCOMMODATION

#### Thursday 20th July 2023, 14.00 - 16.00, Online

East Midlands Councils is hosting a two-hour training session focused on better understanding transition challenges for families, and exploring considerations for easing the process.

Topics will include an overview of the experiences of Afghan families during and after evacuation, subsequent effects on decision-making within families, and ways to re-establish families' sense of safety and trust.

Using a format that explores these topics and exchanges thoughts and experiences between participants, this training aims to inspire and empower local authorities to support the successful relocation of families in British communities.

**Training Objectives** 

- Understand the experiences of Afghans and their potential impacts on perceptions of support offered in the UK
- Understand how trauma can result in specific survival responses that are no longer helpful in the context of getting support in UK systems
- Understand what trauma-informed care is, and how it can potentially be applied to manage the transition of Afghans from temporary accommodation

## FOR PROVISION OF A SCREENING, REFERRAL AND SIGNPOSTING SERVICE FOR ENGLISH LANGUAGE COURSES

East Midlands Councils SMP is looking to commission a provider of a referral and signposting service for English for Speakers of Other Languages for Hong Kong BN(O) Visa Holders in Nottingham and Nottinghamshire.

Approximately 4000 Hong Kong BN(O) status holders have settled in the East Midlands since January 2021 when the visa scheme was launched; the majority of these have made Nottingham and the surrounding boroughs their home.

A recent pilot project has demonstrated the value of a single point of contact for the screening, assessment and referral of HKBNO learners to English Language opportunities.

We therefore seek to continue with this approach to ensure that all HKBNO are able to access appropriate ESOL provision in a timely manner.
