Local Election Update

Local elections were held across a number of local authorities in the East Midlands yesterday. The results at the time of publishing the Policy Brief are;

- Derbyshire County Council CON HOLD
- Leicestershire County Council CON HOLD
- Lincolnshire County Council CON HOLD
- Nottinghamshire County Council CON GAIN from No overall control
- Derby City Council no overall control, the Conservatives are still the largest party on the council

Councils below have yet to declare at time of publishing the EMC Policy Brief, information to follow next week:-

- North Northamptonshire and West Northamptonshire
- Amber Valley and Lincoln City

The Role of the Civic Head, 26 May 2021, 14:00 - 16:00 - The workshop will explore the role of the Civic Head and the expectations of the role from a range of perspectives, including the expectations of the incoming mayor, and those of the public and the council. It will include short introductory sessions on Chairing Full Council, Public Speaking and Social Media [details here]. Audience - the intended audience for this workshop is newly appointed Mayors and deputy Mayors. Cost – £80 per person (plus VAT).

Chairing and effective meetings, Friday 18 June, 10:00 - 13:00 - It covers formal roles such as chairing full council or a planning committee, as well as less formal approaches to chairing eg. for scrutiny activity and public meetings. The focus is guided by delegates and can include problem solving around challenges chairs might face [details <u>here</u>].

Audience - The workshop is suitable for new and continuing chairs. Costs - £75 per person (plus VAT).

Workshop for Chairs and Vice chairs of overview and scrutiny, Thursday 24 June, 10:00 – 13:00 - This workshop will cover the principles behind scrutiny and the different ways of working, as well as skills for the roles. It will look at the formal roles such as O&S committee meetings, less formal approaches to scrutiny such as task and finish groups and inquiry days and the importance of all parts of the system collaborating constructively through scrutiny. [details here]. Audience - for new and experienced non-executive councillors and co-optees involved in O&S activity. Costs - £75 per person (plus VAT).

Workshop for Chairs and Vice chairs of Overview and Scrutiny, Tuesday 29 June, 10:00 – 13:00 - The workshop will focus on the specific tasks of the Chair and Vice-chair in providing leadership to the scrutiny function, exploring the guidance provided by Government in 2019, considering matters relating to the culture and relationships in your council that influence scrutiny, discussing how you build capacity for O&S activity of different types and motivate your members and getting the most out of O&S to make an impact on your council and for its residents [details here].

Migration, Asylum Support and Refugee Resettlement

EU Settlement Scheme - Following the UK's departure from the European Union, EU, EEA and Swiss citizens (including non-EEA citizens) should check whether they need to apply to the UK Government's EU Settlement Scheme (EUSS) to protect their rights and to continue living in the UK. The application deadline for those who were living in the UK by the end of the transition period at 23:00 GMT on 31 December 2020, is 30 June 2021. Applications to the EUSS are free and can be made online at www.gov.uk/eusettlementscheme, where you will also find details of what information you need to apply.
