LGA Apprenticeship Surgeries

UPDATE: Follow-up from LGA/South West Councils Roundtable on Becoming an EPA Assessor

Thanks to everyone who took part in this roundtable. We had around 40 councils attend for at least some of the meeting and had a useful discussion. The slide pack from the meeting is attached to this email. The final two slides contain next steps and the contact details for Fay Edwards and Ed Keirle at South West Councils (SWC) for anyone who is interested in taking forward discussions about using us as an EPAO or becoming an EPA assessor.

The list of Standards on slide 8 details those SWC are currently approved for. They are particularly interested in assessors for the Revs & Bens standard (because they have a large number of registered apprentices on this standard) and possibly the Regulatory Compliance Officer one (they have a smaller pool of assessors for this one, although they don't yet have any registered apprentices).

SWC are also interested to hear from those who may wish to assess the 21 potential new approvals. This is because when they submit the approval request, they must demonstrate expertise and links with the occupational sector, particularly around how they will access assessors. So, having potential assessors to work with will help them to put together a robust approval request.

Going forward, SWC will be working up an Assessor's case study and we will explore other options including a video version.

INLOGOV: Update on Leadership and Management Provision

The Institute for Local Government Studies (INLOGOV) at the University of Birmingham is delighted to continue its Executive Apprenticeship in Public Management and Leadership for the new academic year beginning autumn 2021.
