In Memorium: Rosalie Penn, Dudley Council

I was extremely shocked to receive the news yesterday from colleagues at Dudley that Rosalie (Rose) Penn, Dudley's excellent apprenticeships lead, had died suddenly. Rose was extremely active in apprenticeship circles and even those of you who didn't work with her directly will I'm sure know her either from the apprenticeships network in the West Midlands, through her always helpful comments on the KHUB, from our action learning programme or through our webinars where she was always happy to help with a case study – a testament to the fantastic work she did on apprenticeships.

I wanted to share the message I received from her colleague, Clare Palmer, at Dudley, which I think sums up Rose incredibly well and the sadness all of those who knew her are feeling at her passing.

We are deeply saddened and shocked to share the sudden loss of our dear Colleague and friend, Rosalie (Rose) Penn. Rose was a bright and larger than life character, who had boundless energy and time for anyone. Warm and well-liked, Rose was not only a colleague but someone you could turn to and was considered by myself and many to be a friend.

Rose's passion and strong work ethic stretched beyond the Council and even the borough, committed to fostering a workplace where everyone can learn and grow together. Rose led the Council's drive to launch a successful apprenticeships programme and achieved recognition through Local and National Award schemes. An optimistic team player who cared deeply about her work, Rose has left a hole not just in our team, but in the whole organisation.

Rose remains a testament to the ethos of Dudley Council and will be greatly missed.

For my own part, I always enjoyed working with Rose who was a dedicated professional, good company, and always had a smile. She's positively impacted the lives of countless apprentices in Dudley and will be missed by all who knew her. All of us at the LGA send out our heartfelt condolences to her family and friends.

UPDATE: 5 More days to claim Apprenticeship Incentive Payments

The government announced this week that you have five more days to get your claims in for Apprenticeship Incentive payments. Employers can apply for a payment of £3k for new apprentices with an employment start date from 1 October 2021 to 31 January 2022. The application deadline to claim these payments has now been extended from 15 May 2022 to 20 May 2022.

IFATE Apprentice Panel Recruitment

Recruitment to join the Institute for Apprenticeships and Technical Education apprentice panel has now opened.

The main purpose of the apprentice panel is to ensure the views of apprentices are represented across the work and governance of the Institute. The panel decides which issues to focus on, and panel representatives attend Institute board meetings to advise and challenge on those issues. They also meet regularly with ministers and other government officials to ensure the apprentice experience is front and centre of new policy thinking.

To apply, apprentices need to <u>complete the expression of interest form and upload a copy of</u> <u>their CV</u>. Closing date for applications is midnight on 16 May 2022.
