### **Pooled PAYE**

# Wanted: Council willing to Join Private Beta Testing for Updates to Levy Transfer Process

The Apprenticeship Service is delivering a new service to make it easier for levy-paying organisations to transfer some of their levy funds to other businesses to pay for their apprenticeships training costs. Where a match is made and a connection created, the funds are transferred on a monthly basis. This service will enable levy-paying organisations with unspent levy funds to create public pledges (with criteria), to allow other businesses to apply to them for a transfer of apprenticeship funding.

ESFA are looking for a small number of organisations with unspent levy to be involved in the evaluation of this new service as part of a private beta pilot. The LGA has secured a place as part of this pilot for a local authority to take part.

Participation will involve creating pledge(s) which will later be opened up to other businesses to view and apply to. As part of this private beta, they'll ask participants to commit to:

• 1 preparation session (30mins)

- Completing a diary
- 1 follow-up session(30 mins)

# **REMINDER:** Public Sector Target Reporting Process – Deadline to Complete 30 September 2021

Just a quick reminder for everyone if you've not done it already, that all public sector bodies that employ 250 staff or more need to complete a report on their progress towards meeting the public sector apprenticeships target for the 1 April 2020 – 31 March 2021 period by 30 September 2021.

Submitting this return to the Department for Education alongside supporting evidence that demonstrates you have shown due regard to the target is a legal requirement. Employers are also required to publish the data you submit in a place which is easily accessible to the public, such as on external facing websites for your council.

The reporting process should be completed via the DAS (you can find the link to the form under the 'Apprentices' tab on your DAS account). For more detailed information regarding what data is required, please see the published guidance on <u>gov.uk</u>. #### Degree Apprenticeship consultation:

IFATE has announced a new consultation on Degree Apprenticeships, which sets out proposals for changes to existing policies that effect the development, approval and operation of degree apprenticeships. The consultation sets our five proposed changes, which are:

- better supporting graduate-entry occupations
- integration of on-the-job and off-the-job training
- alignment between apprenticeship knowledge, skills and behaviours and degree learning outcomes
- integration of assessment
- participation of an independent assessor with occupational expertise
