Welcome to the latest LGA Apprenticeships Newsletter. We've got a lot of updates this month including more tools and webinars from the LGA, consultations on standards and development of new apprenticeship programmes, but first a quick reminder to submit your public sector target data...

REMINDER: Public Sector Target Reporting Process – Deadline to Complete 30 September 2022

Just a quick reminder for everyone if you've not done it already, that all public sector bodies that employ 250 staff or more need to complete a report on their progress towards meeting the public sector apprenticeships target for the 1 April 2021 – 31 March 2022 period by 30 September 2022. This is the final year of the target, although reporting on public sector bodies' progress on starts will continue in an altered form annually from 2023.

Submitting this return to the Department for Education alongside supporting evidence that demonstrates you have shown due regard to the target is a legal requirement. Employers are also required to publish the data you submit in a place which is easily accessible to the public, such as on external facing websites for your council.

The reporting process should be completed via the DAS (you can find the link to the form under the 'Apprentices' tab on your DAS account). The LGA Summer National Online Apprenticeships Workshop - Recording

Thank you to everyone who attended and participated in the recent LGA Summer National Workshop on Apprenticeships. In a packed agenda we had updates from the LGA and from South West Councils on their work as an End Point Assessment Organisation, and a Q&A session with two of the Department for Education's Skills Development Managers. Technical problems prevented us splitting into groups as planned, but we also still had a useful discussion between the whole group of attendees on the current challenges and priorities in the post-COVID, post-Public Sector Target environment.

I have attached the slide pack from the session to this email as well – in this you'll not only find the full presentation on South West Councils' work on EPA, but at the end of the pack

we've produced a time-stamped list of when in the recording the various discussions started, which will hopefully allow you to navigate to what you want to listen to more easily.

These workshops are 'pilot' sessions for the time being as we work out what format works best and what you want to get out of the sessions. We plan to hold another one of these in the Autumn (likely early October prior to half term) and we'll confirm the time and date as soon as we're able to.

Are you having problems with Apprenticeship Incentive Payments?

A number of councils at the workshop highlighted the issues they were having with receiving their Apprenticeship Incentive Payments. There appear to be two problems (i) councils seeing their claims being put on hold pending the provision of significant amounts of corroborating information and (ii) councils that have already received at least one incentive payment being asked for significant additional amounts of corroborating information. Many councils were expressing frustration at the amount of additional information they were being asked to supply and the significant delays they were experiencing in getting a resolution, with lengthy delays occurring in obtaining responses when engaging through the helpdesk.

At the workshop, I made a commitment to collate information from councils who are affected by this issue, with ESFA colleagues committing to then follow-up on that information and attempt to unblock the situation.

If your council is affected by this issue, please email me, if you have not done so already, with information on the number of claims you have outstanding and the case number(s) you have been assigned by the helpdesk. I will then collate the information and pass that to DfE to see if they can help to unblock your case. Please email me direct on jamie.saddler@local.gov.uk as soon as possible.

Level 5 Rehabilitation Worker (Visual Impairment) Review and Consultation

The <u>Level 5 Rehabilitation Worker (Visual Impairment)</u> is being reviewed and the changes are now out for consultation. At present the current standard only includes rehabilitation,

however it is proposed that the new Level 5 Vision Impairment Specialist standard will have 2 options:

- Vision Habilitation Specialist (providing support and teaching children and young people with vision impairment)
- Vision Rehabilitation Specialist (providing support and teaching adults with vision impairment)

The review of the standard has enabled the habilitation element to be included, which is key in relating the apprenticeship standard to children and young people, as well as adults as it currently stands.

We would encourage any interested local authorities to take a look at the proposal and complete the survey.

The work on the habilitation element of this standard has been led by Devon County Council's Children's Sensory Team Manager, and the feedback and response received from the sector will be important in helping to ensure that this updated standard can help Children's Sensory Teams across England to deliver the Habilitation training through an apprenticeship route using levy funds.

The closing date for the consultation is Monday 12th September 2022.

University of Birmingham's Systems Thinking and Leadership Practitioner Apprenticeship/MSc Programme

The University of Birmingham have put together a new programme linked to the new Level 7 Systems Thinking Practitioner Standard. They have developed what they think is a unique approach that is intended to cover the formal systems thinking content combined with the leadership capacities needed to actually enable systems change.
