EAST MIDLANDS LOSES OUT ON FUNDING TO PROTECT AGAINST FLOODING

Following a National Audit Office report which confirms that the region is losing out on much-need funding to protect against flooding, East Midlands Councils is calling on the Government to update the model for investment in flood defences.

The NAO's analysis of the Environment Agency's investment programme confirms that the East Midlands receives almost the lowest level funding per property at risk at £3,227, despite large areas of the region being vulnerable to fluvial, surface water, and coastal flooding.

This compares unfavourably to North East which receives almost 4 times the funding at £12,563 per property and the North West at £10,204.

According to Environment Agency data, just 120 properties across Derbyshire, Leicestershire and Nottinghamshire were protected from flooding in 2022/23 after receiving Government funding.

EMC has written to the Government highlighting these concerns, including with the Government's model for investment and business case appraisal that has made it increasingly difficult to secure funding despite a clear need and the obvious value for money that our region offers.

MISSIONS: IMPOSSIBLE? LEVELLING UP THE EAST MIDLANDS

Yesterday, the Department of Levelling Up, Housing and Communities released a "Statement of Levelling Up Missions". This statement includes the government's objectives to reduce geographical disparities and details of how the government proposes to measure progress against these objectives.

DLUHC's publication aligns with EMC's review of the 12 Missions applied to the East Midlands. It leads to several important conclusions & questions, that would merit further consideration over the coming months. You can read this analysis here: **READ MORE** ()

GOVERNMENT ANNOUNCES £600 MILLION FUNDING FOR COUNCILS

On Wednesday 24 January, DLUHC announced councils will receive an additional £600m support package to help deliver key services.

A majority of the extra funding, £500m, will be added to the Social Care Grant.

There will also be an increase to the funding guarantee to uplift Core Spending Power to at least 4% before council tax. The Rural Service Delivery Grant has also been increased by £15m, £3m one off funding has been pledged to councils struggling with Internal Drainage Bord levies
